

What happened last week?

- A bomb attack was organized around 09:30 in front of the entrance gate of the Turkish National Police Headquarters. It was announced that one of the 2 attackers detonated the explosive on his body and the other attacker was killed by the police teams. 2 police officers were wounded in the incident. Ankara Criminal Judicature of Peace on Duty issued an access ban and publication ban on news reports about the attack. PKK's armed force People's Protection Center (HPG) claimed responsibility for the attack.
- Following the attack, detention operations were launched against HDP. Foreign
 Minister Hakan Fidan said, "All infrastructure, superstructure facilities and energy
 facilities belonging to the PKK and YPG, especially in Iraq and Syria, are now the
 legitimate targets of our security forces, armed forces and intelligence elements. I
 advise third parties to stay away from PKK/YPG facilities and individuals."
- Turkish Armed Forces have increased airstrikes on areas controlled by the Autonomous Administration of Northern and Eastern Syria. The Syrian Observatory for Human Rights reported that at least 10 people were killed in airstrikes on various locations in Hasakah province.
- In his speech at the opening ceremony of the Grand National Assembly of Turkey (GNAT), President Erdoğan said "I invite all parties and their MPs, all social segments, all those who have words and proposals on this issue to join our call for a new constitution with a constructive understanding".
- It was announced that the 60th Golden Orange Film Festival, which was at the center of censorship debates, was canceled.
- The Büyük Aile Platform, which organizes hate rallies, submitted a petition to the Parliament asking for the "closure of LGBT organizations" to be discussed in the Constitutional amendment negotiations. The Homeland Party also prepared a law proposal that envisages criminal sanctions against those who target LGBTI+ people.
- In September, inflation increased by 61.53 percent according to the Turkish Statistical Institute (TÜİK) and 130.13 percent according to the Inflation Research Group (ENAG).
- The average cost of living for a family of four in Istanbul increased by 4.62% in September compared to the previous month and by 79.42% compared to the same month of the previous year to 44,561 liras, according to the Istanbul Planning Agency (IPA), affiliated to the Istanbul Metropolitan Municipality.
- President Erdoğan's Protection Department spent 693 million 420 thousand 840 liras in the first eight months of the year. Erdoğan's daily protection cost was 2.8 million liras, equivalent to 245 minimum wages.
- The parliamentary proceedings to lift the immunity of eight deputies, including CHP's Sezgin Tanrıkulu, reached the Grand National Assembly of Turkey.

- Health Minister Fahrettin Koca said, "Covid-19 is a disease that will be fought just like how the flu is now being fought. Measures such as a mass vaccination campaign or closure will never be implemented."
- Lawyer Eren Baskin, the son of Mecit Baskin, announced that the statute of limitations on the murder of his father expired as of September 30, 2023.
- METU Alumni Association announced that its chairman Baki Arslan was banned from entering the school campus until 2090. During the orientation days at Boğaziçi University, student clubs and societies were subjected to pressure and intervention by the school administration and security units.



Freedom House releases 2022 Internet Freedom report

The US-based think tank Freedom House published the <u>"Freedom on the Net 2023"</u> report, which evaluates internet freedom around the world. The report noted that the global internet freedom index has been declining uninterruptedly for 13 years, and this year Turkey, which is in the category of

"countries where the internet is not free", ranked behind countries such as Rwanda, Sudan, Iraq and Libya. According to the report, 2023 was Turkey's worst year ever in terms of internet freedoms.



Journalist Ayşenur Arslan detained

An investigation was launched against journalist Ayşenur Arslan for "terrorist organization propaganda" and "praising the crime and the criminal" after she expressed suspicions about the attack on the Ankara Security Headquarters in her show on Halk TV. The journalist, who was targeted for her statements in the program, was detained and Halk TV terminated Arslan's program Medya

Mahallesi. The Radio and Television Supreme Council (RTÜK) imposed an administrative fine and five program suspensions on the channel.



Journalist Merdan Yanardağ sentenced to 2 years and 6 months in prison

The trial of the channel's Editor-in-Chief Merdan Yanardağ, who was arrested due to his statements about the isolation of PKK leader Abdullah Öcalan in the program "4 Questions 4 Answers" broadcast on TELE1 channel, started at Istanbul 30th High Criminal Court on charges of "making illegal organization"

propaganda" and "praising crime and criminal". The journalist, who had been under arrest for 101 days, was sentenced to 2 years and 6 months in prison and released.



Saturday Mothers detained again

Despite the Constitutional Court's decision on the violation of the Constitutional Court's ruling, the ban imposed by the district governor's office on the protests of the Saturday Mothers, which they have been organizing for 28 years to ask for the fate of their relatives who disappeared in detention and for the perpetrators to be tried, continues.

The police attacked the protest this week as well, beating and detaining 26 rights defenders. On the other hand, the Governorate of Van did not let this week pass by idle, again declaring a protest ban before the protest to be organized in the city in solidarity with the Saturday Mothers.





Journalists on trial for gendarmerie entering the frame acquitted

The lawsuit filed against journalists Fırat Can Arslan and Dilan Babat, who were detained while covering the funeral of slain journalist and writer Nagihan Akarsel, due to "targeting people who took part in the fight against terrorism" at Konya 4th High Criminal Court concluded with an acquittal.



Party executives on trial over poster acquitted

The case against Labour Party (EMEP) Rize Provincial Chairman Hasan Zorlucan and Fındıklı District Executive Kamil Çavuşoğlu, who were charged with "publicly disseminating misleading information to the public" for posters criticizing the government for the measures not taken during the earthquake, was

concluded with an acquittal at Pazar (Rize) 1st Criminal Court of First Instance.



Protesters detained for protesting detention operation

The police prevented the mass gathered in front of the party's provincial office in Beyoğlu, Istanbul to protest the detention of Peoples' Democratic Party (HDP) executives in house raids from making a press statement and attacked the crowd, detaining 10 people.



Students detained for protesting hikes

Eight students were beaten and detained after protesting against the tripling of food prices at Dokuz Eylül University cafeteria.



ECHR rules on freedom of expression violations

The European Court of Human Rights (ECHR) ruled that the convictions of two people who called Erdoğan a "thief" and said "Long live Öcalan" in social media posts violated Article 10 of the European Convention on Human Rights.
